**The National Capital BBQ Battle has been proclaimed “The Official National BBQ Championship” on the floor of Congress. It is a Duel Sanctioned event featuring 6 Unique BBQ Contests.**

KCBS Sanctioned with Chicken, Beef, Pork Ribs & Pork Shoulder Categories, “Perdue Sizzlin’ Chicken Contest”, “Turkey Smoke Contest”, “Smokin’ with Smithfield”, “America’s Best BBQ Sauce”, “National Pork Barbecue Championship” presented by the National Pork Board and the “National Beef Steak Cookoff Championship” Sanctioned by SCA (Steak Cookoff Association) and presented by the Northeast Beef Promotion Initiative.

### **“Giant National BBQ Championship” KCBS (Sunday)**

Teams cook-off in the “Giant National BBQ Championship” sanctioned by KCBS and conducted under KCBS rules. Categories included: Beef Brisket, Chicken, Pork Rib & Pork Shoulder (Butt or Picnic). Prize structure for each category is as follows: 1<sup>st</sup> Place-\$1,000; 2<sup>nd</sup> Place-\$750; 3<sup>rd</sup> Place-\$500; 4<sup>th</sup> Place-\$250; 5<sup>th</sup> Place-\$100. All winners will receive a trophy. Teams competing in all four KCBS Categories qualify to become the Overall Grand Champion of The Giant BBQ Battle with Grand prize of an additional \$3,000 & title of **Giant National Barbecue Champion, Washington, DC.**

### **“Perdue Sizzlin’ Chicken Contest” (Sunday)**

Teams competing in the **Perdue Sizzlin’ Chicken Contest** will receive “Free Perdue Chicken” to prepare for judging in the KCBS Chicken category. The highest scoring KCBS Chicken entry using Perdue Chicken will be proclaimed “**The Perdue Sizzlin’ Chicken Champion.**” Prize structure for this contest as follows: 1<sup>st</sup> Place-\$1,000; 2<sup>nd</sup> Place-\$750; 3<sup>rd</sup> Place-\$500; 4<sup>th</sup> Place-\$250; 5<sup>th</sup> Place-\$100

### **“Smokin’ with Smithfield Rib Contest” (Sunday)**

Teams competing in the **Smokin’ with Smithfield Contest** will receive “Free St. Louis Style Ribs” to prepare for judging in the KCBS Rib category. The highest scoring KCBS Pork Rib entry using Smithfield Ribs will be proclaimed the “**Smokin’ with Smithfield**” winner. Prize structure for this contest as follows: 1<sup>st</sup> Place-\$1,000; 2<sup>nd</sup> Place-\$750; 3<sup>rd</sup> Place-\$500; 4<sup>th</sup> Place-\$250; 5<sup>th</sup> Place-\$100

### **“The National Pork BBQ Championship” (Sunday)**

“**The National Pork BBQ Championship**” is the **Official Pork Championship of the National Pork Board.** Winners of this contest will be determined based on the highest combined scores of the two (2) KCBS Pork entries submitted on Sunday in the KCBS Sanctioned Contest along with the On-Site scores submitted by the National Pork Championship On-Site Judges. The Grand Champion (first-place winner) will be awarded \$1,500, a trophy and the title of “**National Pork BBQ Champion.**” The second-place winner will be awarded \$1,000 and a trophy. Third place will receive \$500 and a trophy. Fourth and fifth place winners will receive trophies.

### **“Turkey Smoke BBQ Cooking Contest” (Saturday)**

The National Turkey Federation’s Turkey Smoke offers teams the opportunity to cook-off on Saturday in the highly competitive Smoked Turkey Category. Teams competing in **Turkey Smoke** will receive “Free Perdue Boneless Turkey Breasts” to prepare for judging. The highest scoring Turkey entry will be proclaimed “**Turkey Smoke Champion.**” Prize structure for this contest as follows: 1<sup>st</sup> Place-\$1,000; 2<sup>nd</sup> Place-\$750; 3<sup>rd</sup> Place-\$500; 4<sup>th</sup> Place-\$250; 5<sup>th</sup> Place-\$100

### **“National Beef Steak Cook-Off” SCA (Saturday)**

Teams competing in the “**Beef Steak Cook-Off**” receive “Free Roseda Ribeye Steaks” to prepare for judging in the Beef Contest on Saturday. Highest scoring Beef entry using Roseda Beef proclaimed, “**National Beef Champion.**” Prize structure for this contest as follows: 1<sup>st</sup> Place-\$1,000; 2<sup>nd</sup> Place-\$750; 3<sup>rd</sup> Place-\$500; 4<sup>th</sup> Place-\$250; 5<sup>th</sup> Place-\$100

**“Nation’s Best BBQ Sauce” (Saturday & Sunday)** Teams will compete throughout the weekend.

The 1<sup>st</sup> Place winner will receive \$1,000 with trophies going to 2<sup>nd</sup> & 3<sup>rd</sup> Place.

### OFFICIAL CONTEST RULES

- 1.) The 2020 Giant BBQ Battle is a **DUEL SANCTIONED EVENT** Saturday contests (National Beef & Turkey Smoke) will be conducted by SCA Rules and Sunday contests (Chicken, Beef, Pork Rib, Pork Shoulder, Perdue Sizzlin' Chicken, Smokin' with Smithfield and Perdue Sizzlin' Chicken Contest) will be conducted by KCBS Rules. Complete rules for competing in both the KCBS and SCA Sanctioned Contests are available on the event website: [www.BBQinDC.com](http://www.BBQinDC.com).
- 2.) **DC HEALTH & SAFETY REGULATIONS** and BBQ Battle Contest Committee Rules must be followed at all times.
- 3.) **ONLY WOOD and/or CHARCOAL** must be used in the actual cooking process. Flammables (propane, compressed or liquid gas, etc.) may be used within the Cooker **ONLY** to **START** the **INITIAL** fire. No type of flammable, other than wood or charcoal, may be used within the Cooker once the meat is placed. Electrical devices may be used within the cooker as long as they do not directly generate cooking heat such as rotisseries, fans & delivery systems for Wood or Charcoal.
- 4.) **MEAT** will be supplied to teams entered into the SCA Steak Cookoff, Perdue Sizzlin Chicken Contest, Turkey Smoke, & Smokin' with Smithfield Contests. Teams must supply meat and cooking supplies for the remaining categories. Meat for both days of the contest (fresh or frozen) must be cooked on-site from a raw state. Meat must be maintained at a temperature below 40 degrees Fahrenheit before cooking, and at or above 140 degrees during & after cooking.
- 5.) **SUPPLIES:** Teams are responsible for providing all of their cooking ingredients, individual cooking devices (portable stoves, wood, or charcoal, etc.) utensils, prep tables, etc. The only thing provided to the contestants is a regulation size cooking area. Electricity is available at an additional cost.
- 6.) **WATER** will be available in selected locations. Teams are required to have 3 large buckets in there are for sanitation (chlorinated water for sterilization (please bring bleach for this), Soapy Water and Clean Water in addition to a handwashing area (soap & water or hand sanitizer). Do not dump Grey Water (Dirty Greasy Water) on the street as it will result in a large fine. Waste tanks will be available on-site for Dumping Dirty Water. If you would like to order your own Waste Tank, Sink or Porta-Potty, please fill out the request form that will be sent to you upon team acceptance.
- 7.) **ELECTRICITY** is not provided unless requested. A 110-volt electrical hookup with Standard Plug-in service will be available to each team at an additional cost. Teams may use own small whisper generators but cannot refuel on-site during event hours when the general public is present.
- 8.) **CONTEST APPLICATION** may be submitted either by mail or email. If submitted by mail, the application must include payment by check made payable to Barbecue Battle Inc. or by Credit card using the attached Credit card Authorization Form and mailed to Giant BBQ Battle 4339 Northview Drive, Bowie, MD 20716. If paying by Credit Card, Contest application along with credit card authorization form may be emailed to [Contest@BBQinDC.com](mailto:Contest@BBQinDC.com). Standard Entry fee includes entry into all contests plus a 20' x 20' team space. The team must fit entirely within the space assigned. Be sure the space you are requesting will accommodate your set up and not protrude into your neighbors' space or fire lane directly in front of your space.
- 9.) **DEADLINE TO ENTER** is April 1, 2020, however, enter as soon as possible as contest fills up quickly.
- 10.) **ACCEPTANCE** into the contest is on a first-come, first-served basis with special consideration going to past teams. Teams will be notified by email once accepted. **The contest fills up fast so enter as soon as possible.** **Acceptance Packets** containing additional information, Rules & regulations will be emailed to each team once accepted into the contest. At that time, you will be instructed to complete the Acceptance Form. Chief Cook must sign & return a Statement of understanding regarding rules, liabilities, regulations, and team responsibilities to be fully entered into the contest. The Contest Committee Reserves the Right to make changes and add additional contest rules as deemed necessary at their discretion in the best interest of the contest. All decisions of the Contest Committee, Chairman and Judges are final. Violations of Contest Rules & Regulations may result in Warning, Disqualification and/or Expulsion from the Grounds. No refunds will be made once accepted into the contest. If not accepted, a full refund will be made.
